*FIRST TRAINING: SEPTEMBER
13TH AT GARFIELD*

An alternative to traditional juvenile court, Youth Courts are established by judges to involve trained high school students in adjudicating minor offenses by peers. Garfield High School students serve as jurors, judges, attorneys, and bailiffs during real court hearings. Students work closely with Seattle University School of Law staff and students, Seattle Municipal Court judges and Seattle Police Department officers. This is a great opportunity for you to have direct impact on social justice in Seattle.

When and where do we meet?

Students volunteering with the Youth Court have two meetings each month. We plan to return to in-person meetings in September, 2021. The court hearings occur once monthly at the Seattle Municipal Court on 5th Avenue downtown. Training occurs once monthly at the Seattle University Law School on 12th Avenue in the Capitol Hill neighborhood near Garfield. Training and Hearings are 1-2 hours long. Community Service Hours are awarded and food provided for all meeting times.

Who can participate?

Any current Garfield High School student can participate.

How to get started?

Attend the first training meeting, then complete short application if would like to continue your involvement.
